**WHEREAS** the World Health Organization has declared the recent outbreak of COVID-19 a pandemic and;

**WHEREAS** the Centers for Disease Control and Prevention, the Illinois Department of Public Health, and the Kane County Health Department have all recommended measures to prevent the spread of illness, which include avoiding close contact with others and;


**WHEREAS** no cases of COVID-19 have been reported within the Kane County Adult Justice Center, cases have been reported in the State of Illinois and Kane County, and therefore, steps must be taken to limit the amount of exposure or contact with others to detainees and staff;

**IT IS THEREFORE ORDERED** that the following sentencing orders in cases currently imposing weekend sentences or periodic imprisonment be temporarily suspended until further Order of the Court: 18 CF 2127, 18 DT 1593, 17 CF 1762, 18 CF 2456, 14 CF 1752, 15 CF 587, 19 CM 1911, 19 CM 1313, 18 CM 3110, 18 CF 2342, 17 TR 26046, 17 CF 1576, 17 CF 1634, 17 TR 18051, 19 TR 23006, 18 TR 24826, 19 TR 12354, 19 CF 853, 18 DT 1427, 19 TR 6624, 19 TR 8126, 18 CM 2467, 16 TR 43111, 18 CF 606, 19 CF 136, 18 DT 1593, 18 CF 598, 18 CF 2158, 18 TR 39773, 17 CM 356, 17 CF 852, 20 CM 118, 16 CM 242, 19 DT 477, 18 DT 555, 14 CF 949, 18 CM 3392, 18 CM 1634, 15 TR 27511, 15 TR 59951. Those defendants ordered to weekend sentencing or periodic imprisonment shall comply with all remaining terms of their sentencing orders during this time, but shall not report to the Kane County Adult Justice Center for service of imprisonment until further order.

**IT IS THEREFORE FURTHER ORDERED** that all future criminal sentencing of weekend imprisonment or periodic imprisonment be hereby suspended until further Order of the Court.
